people live with a mental illness



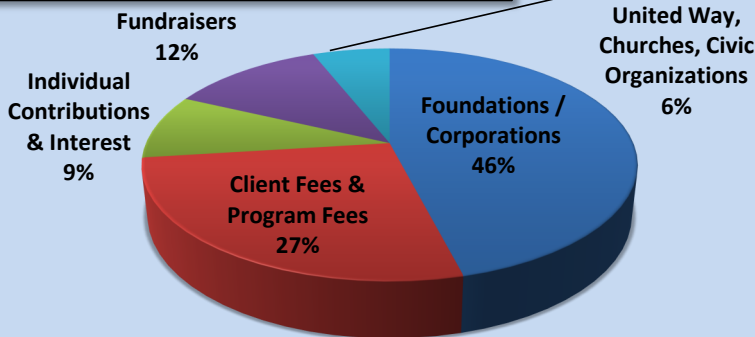
33% of our clients made UNDER \$15,000 per year. 56% were UNEMPLOYED



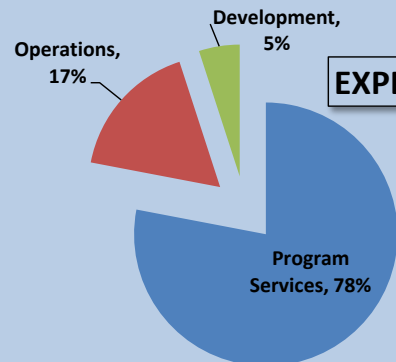
Daemion counselors saw 215 clients in 2012. 128 women and 87 men came for help.
